OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA AND CANADA (EXCLUDING QUEBEC), AGE 21 OR OLDER. VOID WHERE PROHIBITED. U.S. LAW GOVERNS THIS SWEEPSTAKES.

CONSUMER DISCLOSURE: No Purchase or payment of any kind is necessary to enter or win this sweepstakes. You have not yet won. Grand Prize: One seven (7-) day Holland America Line Europe, Caribbean, Alaska, Mexico or Canada & New England cruise for two. ARV: \$3,598 USD. There is one prize out of 200,000 prize notices distributed. Odds of winning depend on the number of entries received. Entries must be submitted by 3/31/18. Sponsor is: Holland America Line N.V., 450 Third Ave. W., Seattle, WA 98119.

1. **HOW TO ENTER:** The entry period for the 7-Day Choose Your Cruise 2017-2018 Sweepstakes (the "Sweepstakes"), sponsored by Holland America Line ("Sponsor"), begins at 12:00 A.M. Pacific Time (PT) on April 01, 2017 and ends at 11:59 P.M. PT on March 31, 2018 (the "Entry Period"). Entrants may submit an entry online or by mail. To enter online, during the Entry Period, entrants may:

1. Access www.enterhal.com (the "Website") and follow the on-screen entry instructions to submit an entry; or
2. Provide all requested information where indicated on any Choose Your Cruise Sweepstakes online advertisement on which an entry form appears and submit your entry.

Entrants entering the sweepstakes by way of online entry will be required to submit his or her name, mailing address, telephone number, e-mail address and date of birth and such other information as Sponsor may require.

To enter by mail, eligible entrants may:

1. Complete fully, by hand, the Choose Your Cruise Sweepstakes entry form found in select mailers and mail it to the address printed on the form; or
2. Hand-print his or her name, mailing address, telephone number, e-mail address and date of birth on a 3"x 5" card, deposit the card in a standard business-sized envelope with sufficient postage affixed, and mail the envelope to: 7-Day Choose Your Cruise 2017-2018 Sweepstakes Entry, Holland America Line N.V., 450 Third Avenue West, Seattle, WA 98119.

Online entries must be submitted and received by Sponsor by 11:59 P.M. PT on March 31, 2018. Mailed entries must be postmarked during the Entry Period and received by

11:59 P.M. PT on April 7, 2018. Normal time rates, if any, charged by Internet service provider will apply. Proof of submission does not constitute proof of entry. Entry times will be determined using Sponsor's computer, which will be the official clock for the Sweepstakes. There is a limit of one sweepstakes entry per person and per e-mail address, regardless of method of entry. No purchase or payment of any kind is necessary to enter or win the sweepstakes.

2. **ELIGIBILITY:** The sweepstakes is open only to legal residents of the fifty United States, the District of Columbia and Canada (excluding Quebec) who are 21 years of age or older as of the date of entry. Employees of Sponsor, its subsidiaries, affiliates, distributors and advertising and promotion agencies, and such employees' immediate family and household members (whether related or not), are not eligible. Void in Quebec, U.S. territories and where prohibited by law. The prize consists of ocean-view stateroom accommodations for the winner and one (1) guest (same stateroom) and most shipboard meals (certain alternate dining options require payment of a fee).
