- 1. HOW TO ENTER:** The entry period for the Best of Alaska 2017-2018 Sweepstakes (the "Sweepstakes"), sponsored by Holland America Line ("Sponsor"), begins at 12:00 A.M. Pacific Time (PT) on April 01, 2017 and ends at 11:59 P.M. PT on March 31, 2018 (the "Entry Period"). Eligible entrants may submit an entry online or by mail. To enter online, during the Entry Period, access [www.halalaska.com](http://www.halalaska.com) and follow the on-screen entry instructions. Each entrant will be required to submit his or her name, mailing address, telephone number, e-mail address and date of birth and such other information as Sponsor may require. To enter by mail, either complete fully, by hand, the Best of Alaska Sweepstakes entry form found in select mailers and mail it to the address printed on the form, or hand-print your name, mailing address, telephone number, e-mail address and date of birth on a 3"x 5" card, deposit the card in a standard business-sized envelope with sufficient postage affixed, and mail the envelope to: Best of Alaska 2017-2018 Sweepstakes Entry, Holland America Line N.V., 450 Third Avenue West, Seattle, WA 98119. Online entries must be submitted and received by Sponsor by 11:59 P.M. PT on March 31, 2018. Mailed entries must be postmarked during the Entry Period and received by 11:59 P.M. PT on April 6, 2018. Normal time rates, if any, charged by Internet service provider will apply. Proof of submission does not constitute proof of entry. Entry times will be determined using Sponsor's computer, which will be the official clock for the Sweepstakes. There is a limit of one sweepstakes entry per person and per e-mail address, regardless of method of entry. No purchase or payment of any kind is necessary to enter or win the Sweepstakes.
