1. **HOW TO ENTER:** The entry period for the 7-Day Choose Your Cruise 2016-2017 Sweepstakes (the "Sweepstakes"), sponsored by Holland America Line ("Sponsor"), begins at 12:00 A.M. Pacific Time (PT) on April 01, 2016 and ends at 11:59 P.M. PT on March 31, 2017 (the "Entry Period"). Entrants may submit an entry online or by mail. To enter online, during the Entry Period, entrants may:

1. Access [www.enterhal.com](http://www.enterhal.com) (the "Website") and follow the on-screen entry instructions to submit an entry; or
2. Provide all requested information where indicated on any Choose Your Cruise Sweepstakes online advertisement on which an entry form appears and submit your entry.

Entrants entering the sweepstakes by way of online entry will be required to submit his or her name, mailing address, telephone number, e-mail address and date of birth and such other information as Sponsor may require.

To enter by mail, eligible entrants may:

1. Complete fully, by hand, the Choose Your Cruise Sweepstakes entry form found in select mailers and mail it to the address printed on the form; or
2. Hand-print his or her name, mailing address, telephone number, e-mail address and date of birth on a 3"x 5" card, deposit the card in a standard business-sized envelope with sufficient postage affixed, and mail the envelope to: 7-Day Choose Your Cruise 2016-2017 Sweepstakes Entry, Holland America Line N.V., 300 Elliott Avenue West, Seattle, WA 98119.

Online entries must be submitted and received by Sponsor by 11:59 P.M. PT on March 31, 2017. Mailed entries must be postmarked during the Entry Period and received by

11:59 P.M. PT on April 7, 2017. Normal time rates, if any, charged by Internet service provider will apply. Proof of submission does not constitute proof of entry. Entry times will be determined using Sponsor's computer, which will be the official clock for the Sweepstakes. There is a limit of one sweepstakes entry per person and per e-mail address, regardless of method of entry. No purchase or payment of any kind is necessary to enter or win the sweepstakes.

2. **ELIGIBILITY:** The sweepstakes is open only to legal residents of the fifty United States, the District of Columbia and Canada (excluding Quebec) who are 18 years of age or older as of the date of entry.
